1 - The status of the institution, the content of the educational program and the admission of the applicant to the program are searched, confirmed and verified by the committee prior to the review of the grant application. Once admission of the grantee to the program (master in palliative care, post graduate degree in palliative care or research course in palliative care) is confirmed, the tuition fees are wired directly to the University or academic Institution. Traveling fees and other funds to cover books and other expenses are wired directly to the grantee. Confirmation of the receipt of the funds is requested by the office. Students have to comply with a set number of criteria - when these are not met, the funds are requested to be returned to the institution. Constant communication is kept between the office and the institutions and the students.

2 - Individuals who receive grants or benefit from grants in institutions which receive funding are required to complete and send a written report, which includes a description of how the funds were used, the progress achieved with the funding and the programs.
