Through this program, the IAHPC, in collaboration with other NGOs, seeks to ensure that access to palliative care and to essential medicines for pain relief are included in international policy documents and strategies, as components of the right to health. We work on the drafting and implementation of resolutions, agreements and strategies with international agencies of the United Nations and, by invitation, with governments. We also work with regional NGOs in Africa, Asia, the Americas and Europe to strengthen palliative care programs and to advance education and knowledge.

Membership Program \$57,895

Membership constitutes membership to the organization. Membership fees are set based on the countries' income with the goal of facilitating enrollment of individuals from countries with limited resources. The database includes hundreds of scientific journals and publications, including palliative care publications.

Traveling fees and other funds to cover books and other expenses are wired directly to the grantee. Confirmation of the receipt of the funds is requested by the office. Students have to comply with a set number of criteria - when these are not met, the funds are requested to be returned to the institution. Constant communication is kept between the office and the institutions and the students.
- 2 - Individuals who receive grants or benefit from grants in institutions which receive funding are required to complete and send a written report, which includes a description of how the funds were used, the progress achieved with the funding and the programs.
