Students have to comply with a set number of criteria - when these are not met, the funds are requested to be returned to the institution. Constant communication is kept between the office and the institutions and the students.
- 2 - Individuals who receive grants or benefit from grants in institutions which receive funding are required to complete and send a written report, which includes a description of how the funds were used, the progress achieved with the funding and the programs.
